

PRIVACY POLICY

Effective Date: January 27, 2015

Judgmentinterestcalculator.com (the “Website”) and its related services and products, including without limitation, the Judgment Interest Calculator for Michigan (the “Application”) is owned and operated by Mokasoft, LLC (“Mokasoft” or “We”), a Michigan limited liability company. By visiting the Website or using the Application, you understand and agree to accept and adhere to the following terms and conditions as stated in this Privacy Policy, along with the terms and conditions as stated in our Terms of Use Agreement. Mokasoft has adopted this Privacy Policy (“Privacy Policy”) to inform you that it collects personal information (“Personal Information”) when you use the Website or Application and to explain how this Personal Information is used.

1. Mokasoft may collect the following Personal Information from you:

1) Any information that you submit to the Website, Application, Youtube, Social Media or similar third party sites or applications; 2) First and last name; 3) Email address; 4) Country; 5) Business name, business website, business email address; 6) Payment information; 7) Other required account or other information visible to the User as requested by the Website or Application; 8) Your IP address; 9) Phone number; 10) Address book and contacts; 11) Mobile device ID, device name, and OS name and version; 12) Your geolocation; 13) Your use of the Website and Application; 14) Information stored in cookies, pixel tags, or web beacons; 15) Analytic data from Google Analytics; 16) Account holder and payment information; and 17) Any other additional analytic data that you voluntarily submit to the Website or Application

Mokasoft may collect this personal information from you through various channels, including, but not limited to, through your voluntary submission of information to the Website or Application, through requests initiated by you through the Website or Application, through communication with third parties such as banks, through the collection and analysis of information concerning your computer and browsing activities, through the use of cookies, web beacons, pixel tags, Google Analytics, and through other sources permitted by law.

2. Use of Cookies and Other Tracking Techniques

Mokasoft may collect Personal Information from you through its use of cookies or other tracking techniques. Cookies allow the Website and Application to recognize your computer or mobile device and preferences when you revisit the Website or Application. Session cookies help to remember your preferences on a single visit to the Website or Application and your browser will normally delete these session cookies upon closing. Web beacons and tracking pixels are objects embedded in a web page that allow Mokasoft to analyze whether a user has visited a specific page. The Personal Information

collected through the use of these cookies and tracking techniques may be used for advertising purposes, whether contextual or otherwise, and may be shared with Mokasoft's advertisers to provide its advertisers with information on the demographics or preferences of the Website or Application's users.

Your web browser or mobile device may provide you with the ability to block or limit these cookies and tracking techniques. If you object to Mokasoft's use of cookies and other tracking techniques, you are advised to adjust your web browser or mobile device's settings accordingly.

3. Mokasoft uses Personal Information to:

Provide you with the Website and Application, process any requests made by you, process any business contemplated by the Website or Application, communicate with you, identify and fix problems with the Website or Application, update you on changes to the Website or Application, communicate with you concerning your Account, to complete a transaction you initiated, and to update you on Mokasoft's services offered through the Website or Application or the services of third parties.

Mokasoft will never sell, share, or rent individual personal information with anyone without your advance written permission or unless ordered by a court of law. Information submitted to us is only available to employees managing this information for purposes of contacting you or sending you emails based on your request for information and to contracted service providers for purposes of providing services relating to our communications with you.

Except as otherwise stated herein, Mokasoft will not sell, transfer, or lease your Personal Information to any individual, business, or government entity except to: (1) respond to authorized information requests by government authorities; (2) to respond to a court order or subpoena; (3) to protect the employees, independent contractors, users, members, officers, directors, or shareholders of Mokasoft;

(4) to help prevent against fraud or the violation of any applicable law, statute, regulation, ordinance, or treaty; or 5) enforce the terms and conditions of this Privacy Policy or other policy or agreement of Mokasoftware.

Mokasoftware reserves the right, but has no obligation, to report to law enforcement any Personal Information or User Generated Content at any time and for whatever reason, in its sole and absolute discretion.

The Personal Information that you provide to Mokasoftware may be publicly displayed. You are solely responsible for the protection of any Personal Information that you submit to the Website or Application, and you are advised to review that Personal Information before you submit it to the Website.

4. Mokasoftware stores your Personal Information and other information in the following manner:

Mokasoftware may remove the cached content at any time, within its sole discretion, although Mokasoftware cannot guarantee that the cached content will be permanently deleted. Accordingly, any User Generated Content that you send or receive is done so at your own risk. Mokasoftware does not provide any means for you to delete the cached content.

Your Personal Information is stored and processed on computers in the United States and, through your use of the Website or Application, you unequivocally consent to the processing and storage of your Personal Information within the United States. Be advised that the laws of the United States may not be as protective of your privacy as those in your location. You understand and agree that Mokasoftware may continue to store your information after you cease use of the service or disable your Account. Please also be aware that your Personal Information and User Generated Content may be transferred to and maintained on servers or databases located outside your state, province, or country.
